My aspirations to be a public administrator stemmed from an early age. When I was younger, I would go to various city halls with my father, a roofing contractor, to obtain building permits. To this day, he advises me not to be a contractor, but to be on the other side of the counter - issuing permits. I am pursuing a Master of Public Administration at USC Sol Price School of Public Policy because my goal is to mentor future public administrators. Graduate school is an opportunity for me to develop leadership skills that extend beyond merely managerial abilities, and this experience will help to establish my credibility as a public servant. The Wes McClure Scholarship will help me undertake this opportunity.

Being diagnosed with cerebral palsy encouraged me to help others. Working for the City of Indian Wells taught me that local government is an outlet for accomplishing this. I admire municipalities' ability to enact public policy with a direct and visible impact. During my undergraduate studies, I have also been able to apply skills from the workplace in the classroom. My professional experience taught me how to resolve issues from a broader perspective. Similarly, my academic experience has taught me how to manage my time more wisely. The combination of these experiences has prepared me for larger challenges that lie ahead.

In the short-term future, I see myself holding a position where I would utilize my generalist skill set. This will allow me to work in multiple departments within an organization. One of my career goals is to be in a position that does not limit me to a specific department. I want to spend the first few years of my career not limited to one specific department, so I can build a well-rounded skillset that will allow me to make informed decisions involved in any aspect of local government. For the long-term, I want to take a role that is responsible for public policy formation and promotion of organizational development. Public policy provides possible solutions to problems facing society. Promoting organizational development increases agencies' efficiency and productivity. I want to implement public policy because I hope to strengthen communities' trust in local government. I want to promote organizational development because increasing productivity will help change peoples' perception of government. More specifically, I want to work at a municipality because I want to be able to see a direct visible impact of my work in both areas. Throughout my life, I have received assistance and accommodations for my cerebral palsy and this has inspired me to want to help others. Having cerebral palsy has taught me to accept situations that are out of my control and inspired me to change the ones I can. I have also learned that the choices I make, and not my disability, define me. When I was younger, I wanted to join the military because I knew I wanted to make a difference. Eager to learn more about career possibilities, I spoke to a recruiter and learned that cerebral palsy was a disqualification. Instead of letting this discourage me, I shifted my focus to working for the government where I still have an opportunity to achieve my goal of making a difference.
